Include a **copy of negative Coggins** within last 12 months for all out-of-state horses. Health certificate required for all out-of-state horses- bring with you. In the event of a vesicular stomatitis outbreak, Health Certificates must include a VS statement, and may be required for in-state horses. All attachments must be included with entry. Failure to do so could result in denial of the entry. Changes: \$30 per horse/rider after Closing Date, space permitting. **Draw checks to WWMSEA.**
